# \$1.9 MILLION DONATION

noun: 1. a person who seeks to promote the welfare of others, esp. by the generous donation of money to good causes.

It's gratifying and an honor to help raise funds and support for St. Mary's Medical Center. Donor gifts of any size usually involve a chain of very personal interactions among the patients and their families with physicians, nurses, and hospital staff. Through the years, the Foundation has seen many heartening stories, but there are always pleasant surprises. Recently, St. Mary's received a \$1.9 million bequest from Mrs. Martha Suzuki, who was not a patient of the hospital.

From the 1960s to the early 1990s, the Takahashi retail stores and national wholesale business were known for high-end, fashionable Japanese imports. In San Francisco, there was a large very trendy store in Ghirardelli Square and the wholesale operation was housed in a brick building where the family name can still be seen in the city skyline. The founders were Henri and Tami (Tomoye) Takahashi. Tami's sister Martha and her husband Risaburo Suzuki managed the large import business.

Before WWII, the two sisters grew up a few blocks from St. Mary's. Their father was a successful businessman and owned one of the first cars in San Francisco. He would drive the girls everywhere. Although Martha was known as an astute businesswoman and investor, she was also a collector and admirer of Japanese culture and art. She had a great passion for purchasing unusual cars. Martha often claimed that she inherited this passion from her father. Throughout her life, Martha owned just about every collector car available. Her last was a limited model BMW that took five years to build and could go up to 180 miles per hour. Just a few months prior to her passing, she still loved to drive her car 90 to 100 miles down the freeway.


With such a successful year for Doctor's Day 2013, we hope to have another flourishing celebration for 2014.

and an anonymous friend of Fred's, donated the funds that have allowed us to purchase new Breast Digital Mammography with Tomosynthesis and Whole Breast Ultrasound machines. This new technology will detect breast cancers at a smaller size, especially in women with dense breasts.

Fred said he wanted to make this investment in St. Mary's for a number of reasons:

Our refurbishment of the Sister Diane Grassilli Center for Women's Health and the installation of the new digital mammography unit in Phase I was a success! We were recognized as a Breast Center of Excellence by The American College of Radiology, which is also a tremendous honor. Raising the first \$750,000 was a very strong beginning, but we knew we had much more to do.

Just a few months into our plans for Phase II, two very generous donors stepped forward, and we were launched ahead with a gift of \$617,320. Fred Ruhland, the husband of our late board member Jena Ruhland, *"I wanted to honor Jena by helping future patients of St. Mary's in a very tangible* 

way. Jena knew this technology was

just around the corner and had hoped that it would be a part of the detection, diagnosis and care that St. Mary's could provide for the women who come to the Center. My second reason for supporting this effort was to give St. Mary's a 'leg up' in technology in the San Francisco medical community. I wanted state-of-the-art equipment to match the great care that Jena received during her time at St. Mary's."

Medical Director for the Center, Dr. Pamela Lewis stated, "We are thrilled with this new technology. At the present time, we are the only hospital in San Fran-

cisco to earn accreditation for ultrasound. We're also working on our accreditation as a National Certified Breast Program, which is very difficult to achieve. Only a few places around the nation are nationally accredited."

The St. Mary's Medical Center Foundation is grateful and filled with appreciation for Fred Ruhland's leadership and willingness to support our Center for Women's Health with such a generous donation.

The sisters became widowed a number of years ago and were very close. They lived in the same retirement building and were visited often by the Foundation staff. Tami was a St. Mary's patient and Martha was not. But, any solicitations and discussions about the gifts were done with Martha because she handled all the family business. When we would unsuccessfully solicit large gifts, which was often, she would smile and simply say, "don't worry, I grew up down the block from St. Mary's and always think of it as my hospital."

Like any good fundraisers, we kept asking and she kept smiling.

In early 2012, Martha peacefully passed away and we were notified of her extremely generous gift in support of cardiology. We now realize that she was giving us an allknowing and very modest smile -- she knew all along that her gift to St. Mary's would be one of our largest gifts in decades.

In addition to supporting St. Mary's, she helped establish the Henri & Tomoye Takahashi Charitable Foundation. With her sister, they have changed and improved the lives of thousands of people. She always believed that it is not about how much money you have, but rather what you can do to make a difference in people's lives. In 2010, Martha was awarded the Order of the Rising Sun, Gold and Silver Rays from the Government of Japan for her contribution toward improving U.S. - Japan relations. Martha is survived by her sister Tomoye Tami Takahashi, her niece Masako Takahashi, nephew Norman Takahashi, and sister-in-law Setsuko Suzuki of Tokyo, Japan.



Ct. Mary's Medical Center has Obeen recognized as one of the top 100 hospitals in the nation with an outstanding orthopaedic program by Becker's Hospital Review. All hospitals included on this list have orthopaedic surgery departments, programs or dedicated centers that have earned considerable recognition.

St. Mary's orthopaedic department is comprised of practicing physicians, cutting-edge orthopaedic research and innovations, along with a training program for new generations of surgeons using state-of-theart techniques. All these converge in our hospital, known for a superior standard of compassionate care.

St. Mary's Medical Center has pioneered orthopaedic care since it performed the first total hip replacement in California in the 1970's. Total joint replacement continues to be the cornerstone of high quality services St. Mary's provides, and today

surgeons continue to use the latest techniques, such as the anterior approach to hip replacement.

Also among the orthopaedic services offered at St. Mary's is the renowned Spine Center, the oldest continuously operating multidisciplinary spine center in the western United States. In 2005, top surgeons at St. Mary's invented the X-Stop implant for the treatment of spinal stenosis and are recognized year after year by Becker's Spine Review "Top Spine Surgeons to Know."

St. Mary's has also been recognized for rehabilitation programs, which include occupational therapy, outpatient therapy and the Acute Rehabilitation Center.



#### Highlights of Foundation Grants Administered

In FY 2013, a majority of the capital transfers supported the Center for Women's Health with new machines, furnishings, and design of the center.

Other highlights:

# **Clinic Receives an Electronic Upgrade!**

'n April of 2013, the Sister Mary Philippa Health Clinic "went live" with eClinicalWorks (eCW), an industry-leading Electronic Health Record (EHR) system, which was made possible with funding from St. Mary's Foundation.

The program has made a huge impact on the daily work for physicians, staff, and patients allowing for a more integrated system as well as a more complete patient record. With the new system, records that patients acquire from various hospital departments become integrated into one, so that whoever is assessing the patient can have a better understanding of their medical history. Information ranging from who their primary care physician is and what prescriptions are currently prescribed, to whether a patient needs translation services, are all in one place and easily accessible. This integrated form of data mining, allows easier management and faster service. The use of the Clinic EHR has obviated the use of manual charts and labor intensive review of clinical data.



involved Nurse Manager Mary Karr, Clinic Director Barry Lawlor and Medical Director Ingrid Block working with outside consultants to plan for the abstraction of over 3,000 patient charts and the development of work flows for every process with an EHR environment. The Clinic hired a full time Analyst -Rochelle Abbas – who manages the EHR and has been the architect of all customizations to suit the complex needs of an internal medicine and multi specialty clinic supported by residents and over 55 contract physicians.

Sister Mary Philippa Health Clinic is at the core of St. Mary's Medical Center's response to community needs. It provides a coordinated program of comprehensive outpatient health services. These services include a broad spectrum of care including, but not limited to, adult primary care, medical and surgical specialties, HIV care, social services, translation services, patient advocacy, diabetes education, nutrition, and pharmacy services. The Clinic serves a socially and ethnically diverse population of patients who are treated by attending physicians, residents, fellows, nurses and other staff.

This project has been one of the largest and most comprehensive system changes that Dignity Health

has implemented. The Clinic has become a leader in developing strategies and the execution of EHR systems among all clinics in the Dignity Health system. Training in the use of EHR was a huge undertaking and involved multiple training sessions for various groups of physician contractors, residents, nurses, medical assistants, interpreters, social workers and case managers.

The overall planning for the EHR migration was led by Dr. John Selle. A year-long planning process
